Na osnovu potrebe za ishodovanjem potrebnih dozvola za izvore nejonizujućih zračenja na osnovu Zakona o proceni uticaja na životnu sredinu i na osnovu važećeg ugovora o pružanju usluga broj 15793 (u daljem tekstu: Ugovor) **OVLAŠĆUJE** se privredno društvo **W-LINE D.O.O.**, sa sedištem u Beogradu, Ikarbus 3, Nova 19, 11080 Beograd, MB 20279648, odnosno njegovi zaposleni koji obavljaju poslove u okviru izrade dokumentacije i pribavljanja dozvola, u svemu prema važećem **Spisku ovlašćenih zaposlenih lica**, koji čini sastavni deo ovog punomoćja kao **Prilog 1**, da prikupljaju potrebnu dokumentaciju za podnošenje zahteva za procenu uticaja, podnose zahteve i podneske organima uprave na lokalnom nivou ili ovlašćenom ministarstvu, oglašavaju podnete zahteve i doneta rešenja i obavljaju potrebne radnje za ishodovanje dozvola za postavljanje i rad izvora nejonizujućih zračenja baznih stanica i drugih telekomunikacionih objekata u vlasništvu A1 Srbija.

Potpisom ovog punomoćja A1 Srbija potvrđuje da je privredno društvo koje je osnovano i postoji u skladu sa zakonima Republike Srbije i da su potpisnici ovlašćena lica za zastupanje ovog privrednog društva i da mogu preduzimati pravne radnje u ime i za račun privrednog društva.

Based on the need to obtain the necessary permits for sources of non-ionizing radiation based on the Law on Environmental Impact Assessment and pursuant to the applicable Service Agreement No. 15793 (hereinafter: Agreement), the company **W-LINE D.O.O.**, having its registered office in Belgrade, Ikarbus 3, Nova 19, 11080 Beograd, registration number: 20279648, i.e. its employees performing the works within the scope of documentation preparation and obtaining permits, all in accordance with the current **List of Authorized Employees**, which constitutes integral part hereof as **Appendix 1**, are HEREBY **AUTHORIZED** to collect the documentation required for submitting requests for impact assessment, submit request and submissions to administrative bodies at the local level or the authorized ministry, advertise the submitted requests and adopted solutions and perform the necessary actions to obtain permits for the installation and operation of sources of non-ionizing radiation of base stations and other telecommunications facilities owned by A1 Srbija.

By signing this power of attorney, A1 Srbija acknowledges to be a company established and existing in accordance with the laws of the Republic of Serbia and that the signatories are authorized to represent this company and with capacity to take legal actions for and on behalf of the company.

This power of attorney shall be valid from 23 January 2025 to 23 January 2026.
